At last a new edition of The Journal of Psychosocial Studies...

Even though it needs to be acknowledged that the interval between this and the last volume has been somewhat extended, this current edition can announce improvements in the position, structure and editorial personnel of the Journal, all of which should guarantee far more, and more regular, publication and a greater presence in the market. One of the most significant changes has been the formal adoption of the JPSS by the Association for Psychosocial Studies as *the* Journal of the Association. This seems a good move all round.

It is beneficial to the APS to have its own journal, for raising the profile and the status of the Association and its membership. It can be used for specifics, for example promoting APS events, and the annual conference and is part of a consistent drive towards increasing the visibility and the membership of the APS. We believe that the Association and the Journal will both benefit from seeing the Journal as integral to the APS (and vice versa), and of the process of sharing interests that follow from this. It is also useful for APS members generally, because it offers a space to publish, with expert reviewers' feed-back, and it is intended that the Journal Editorship will offer 'how to write for publication' sessions at annual conferences and any other appropriate events the APS devise. For the Journal, having a presence on the APS website provides consistency, and an appropriate and expected place for anyone interested in psychosocial studies to locate the Journal to search or browse its original psychosocial papers.

The second significant change for the journal is that Helen Lucey has stepped down from her role as co-editor after six years of hard work. This was a difficult decision for her to make, as the editorial partnership has been a great experience – intellectually stimulating, with much laughter and many glasses of wine. But Helen left her academic post in 2015 to concentrate on training as a homeopath and now that she's about to qualify, she wants to focus her energies on building a clinical practice. She hasn't left the journal altogether though – she'll continue to make a significant contribution as a board member. We warmly welcome David
